

# CITY OF CREIGHTON

## MINUTES OF COUNCIL MEETING

A regular meeting of the mayor and council of the City of Creighton, Nebraska, was held in the meeting room at Creighton Public Library in said city on the 14th day of July 2005 at 7:30 o'clock p.m. Present were: Mayor Stokes; Council members: Anderson, Borgmann, Cox, Keck; Administrator/Clerk/Treasurer Jacobs; Deputy Clerk Johnson; Police Chief Henery; City Attorney Curtiss.

Notice of the meeting was given in advance thereof by posting in at least three public places as shown by the certificate of posting notice attached to these minutes. Notice of the meeting was simultaneously given to the mayor and all members of the city council and a copy of their acknowledgement of receipt of notice and the agenda is attached to these minutes. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

The meeting was called to order by the mayor. The mayor presided, and the clerk recorded the proceedings. Also present during the meeting were Jerry Pospisil, Brian Kimble and Cliff Dennis.

Heard City Attorney's report.

Police Chief Henery reviewed the police report. Chief Henery will be sending nuisance letters and, if no action is taken by the property owners, the City will proceed with the cleanup and bill the property owner or file a lien on the property. Letters will also be sent to property owners who have trees hanging over sidewalks and/or streets.

Discussion was held on hiring a part time police officer. Approved paying a part time officer \$15.00 per hour. RCV: Ayes: Anderson, Borgmann, Cox, Keck. Nays: None.

Approved a \$750.00 a year pay increase for the Deputy Clerk. RCV: Ayes: Anderson, Borgmann, Cox, Keck. Nays: None.
