MINUTES OF SPECIAL COUNCIL MEETING
Tuesday, April 11, 2017

A special meeting of the Mayor and Council of the City of Creighton, Nebraska was held in the meeting room of the Creighton City Offices at 809 Main Street in said City on the 11th day of April, 2017, at 11:00 a.m. Present were: Mayor Chris Patrick and Council members MaryAnne Block, Bob Jensen, Drew Nelson, Mike Nutting; Administer/Clerk/Treasurer (ACT) Lindsay Nelson; Deputy Clerk Ronda York; Sewer Commissioner Alan Novacek; Water Commissioner Kevin Sonnichsen, and Chris Miller, City Engineer.

Notice of the meeting was given in advance thereof by posting in at least three public places, as shown by the certificate of posting notice attached to these minutes. Notice of the meeting was given to all members of the City Council, and a copy of their acknowledgment of receipt of notice and the agenda is attached to these minutes. Mayor was given notice before the meeting. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

The meeting was called to order by Mayor Patrick at 11:00 a.m. Mayor Patrick presided, and Deputy Clerk York recorded the proceedings.

The Pledge of Allegiance was recited by those in attendance.

Mayor Patrick publicly stated to all in attendance that a current copy of the Nebraska Open Meetings Act was available for review and indicated that a Nebraska Open Meetings Act poster was on display on the west wall of the meeting room.

Nelson made a motion seconded by Block to approve the minutes from the April 5, 2017 Special Meeting. RCV; Ayes: Block, Jensen, Nelson, Nutting. Nays: None.

Mayor Patrick turned the meeting over to Chris Miller, City Engineer, to update everyone on sewer project and discuss upcoming projects. A map was handed out that highlighted in red repairs that were originally bid. The other sections are highlighted in green that have been CCTV'd and the need to be addressed as they are priority for repairs. There was a long discussion regarding repairing the sewer lines highlighted in green with the remaining funds.

Jensen made a motion seconded by Nelson to approve to spend up to the budgeted amount of \$1,058,000.00 to finish sewer upgrades that are highlighted in red and green on the map provided by Chris Miller. RCV; Ayes: Block, Jensen, Nelson, Nutting. Nays: None.

All business complete, Nutting made a motion to adjourn. Jensen seconded the motion. All present in favor. Council adjourned at 11:57 a.m. Meeting of this date was held pursuant to published notice in the Creighton News, Creighton, Nebraska.
